The 2014 Annual Meeting of Stockholders of Accuray Incorporated will be held on Thursday, November 20, 2014 at 9 am PST at Accuray's corporate offices located at 1310 Chesapeake Terrace, Sunnyvale CA 94089.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** the election of directors in Proposal 1 and, **FOR** Proposals 2 and 3:

1. To elect two Class II directors named in the proxy statement to hold office until our 2017 Annual Meeting of Stockholders, or until their respective successors have been duly elected or appointed;
2. An advisory vote to approve the compensation of our named executive officers;
3. To ratify the appointment of Grant Thornton LLP as our independent registered public accounting firm for the fiscal year ending June 30, 2015; and
4. To transact any other business as may properly come before the meeting, including any motion to adjourn to a later date to permit further solicitation of proxies, if necessary, or any adjournment or postponement of the meeting.
